THE NOMINATION COMMITTEE'S PROPOSALS FOR HUMANA'S 2022 ANNUAL GENERAL MEETING

The Nomination Committee of Humana AB, comprising Fredrik Strömholm, appointed by Impilo Care AB (Chair of the Committee); Alexander Kopp, appointed by Incentive AS; Mats Hellström, appointed by of Nordea Funds Ltd; Simone Hirschvogel, appointed by SEB Investment Management AB and Sören Mellstig, Humana's Chair of the Board, presents the following proposals prior to the Annual General Meeting of Humana on May 10, 2022.

Chairman of the Annual General Meeting

Sören Mellstig to be chairman of the AGM, or if he is prevented from attending, the person the nomination committee proposes in his place, shall be elected to chair the meeting.

Number of Board members and auditors

The number of Board members to be six Board members appointed by the Annual General Meeting, without deputies.

The Company to have one auditor without a deputy.

Auditor

In accordance with the Audit Committee's recommendation, the re-election of KPMG AB as auditor until the end of the AGM 2023.

Neither the Nomination Committee's nor the Audit Committee's recommendation of auditor have been subject to influence from third parties or been forced by any contractual terms that restricted the freedom of choice in the election of auditor.

Directors' fees

The proposal is that the fees should be paid as follows:

- Chair of the Board: SEK 725,000 (700,000)
- Other non-executive directors: SEK 260,000 (250,000)
- Chair of Audit Committee: SEK 120,000 (120,000)
- Other members of the Audit Committee: SEK 50,000 (40,000)
- Chair of the Remuneration Committee: 90,000 (60,000)
- Other members of the Remuneration Committee: SEK 40,000 (20,000)

The proposal means total Board remuneration of SEK 2,505,000 (2,310,000).

Auditors' fees

Fees will be paid to the auditor in accordance with approved invoice.

Election of Chairman and other Board Members

Re-election of Board members Karita Bekkemellem, Kirsi Komi, Monica Lingegård, Sören Mellstig, Anders Nyberg and Fredrik Strömholm.

Re-election of Sören Mellstig as Chairman of the Board.
