### **Chairman of the Annual General Meeting**

Sören Mellstig to be chairman of the AGM.

#### **Number of Board members and auditors**

The number of Board members to be six Board members appointed by the Annual General Meeting, without deputies.

The Company to have one auditor without a deputy.

#### Auditor

In accordance with the Audit Committee's recommendation, the re-election of KPMG AB as auditor until the end of the AGM 2022.

Neither the Nomination Committee's nor the Audit Committee's recommendation of auditor have been subject to influence from third parties or been forced by any contractual terms that restricted the freedom of choice in the election of auditor.

### Directors' fees

The proposal is that the fees should be paid as follows:

- Chair of the Board: SEK 700,000 (600,000)
- Other non-executive directors: SEK 250,000 (230,000)
- Chair of Audit Committee: SEK 120,000 (100,000)
- Other members of the Audit Committee: SEK 40,000 (33,000)
- Chair of the Remuneration Committee: 60,000 (50,000)
- Other members of the Remuneration Committee: SEK 20,000 (16,500)

The proposal means total Board remuneration of SEK 2,290,000 (2,278,500).

#### Auditors' fees

Fees will be paid to the auditor in accordance with approved invoice.

#### **Election of Chairman and other Board Members**

Re-election of Board members Karita Bekkemellem, Kirsi Komi, Monica Lingegård, Sören Mellstig, Anders Nyberg and Fredrik Strömholm. The director Magdalena Gerger has declared that she is not available for re-election. Re-election of Sören Mellstig as Chairman of the Board.
